

THE CORPORATION OF THE CITY OF PORT COLBORNE

BY-LAW NO. 5878/132/12

BEING A BY-LAW TO AMEND BY-LAW 3475/56/97, AS AMENDED, BEING A BY-LAW ESTABLISHING PARKING LOTS IN THE CITY OF PORT COLBORNE AND FOR REGULATING, SUPERVISING & GOVERNING THE PARKING OF VEHICLES THEREIN & THEREON & TO PROHIBIT THE PARKING OR LEAVING OF MOTOR VEHICLES, PRIVATE PROPERTY OWNED OR OCCUPIED BY THE CORPORATION OF THE CITY OF PORT COLBORNE OR ANY LOCAL BOARD THEREOF

WHEREAS the Council of the Corporation of the City of Port Colborne enacted By-law 3475/56/97, Being a By-law to Provide for Establishing Parking Lots in the City of Port Colborne and for Regulating, Supervising and Governing the Parking of Vehicles Therein and Thereon, and to Prohibit the Parking or Leaving of Motor Vehicles on Private Property Owned or Occupied by the Corporation of the City of Port Colborne or Any Local Board Thereof, on the 28<sup>th</sup> day of April 1997;


AND WHEREAS the Council of the Corporation of the City of Port Colborne approved the Department of Planning and Development Report 2012-80, Municipal Parking Lot By-law Amendments, on the 26<sup>th</sup> day of November 2012.;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF PORT COLBORNE ENACTS AS FOLLOWS:

1. That Bylaw 3475/56/97, as amended, be amended by adding thereto the following:
  - a) Section 1 Definitions– “Conditional Permit” means a permit issued by the Corporation of the City of Port Colborne for the parking of Large Motor Vehicles in parking lots described in Schedule ‘A’;
  - b) Section 1 Definitions – “Large Motor Vehicle” shall mean a commercial motor vehicle, bus, school bus or mobile home”.
  - c) Schedule ‘A’ , Section 9 delete the name “Teeder Kennedy Youth Arena – 550 Elizabeth Street” and insert “Vale Health and Wellness Centre – 550 Elizabeth Street”;
  - d) Schedule ‘A’ add the following lots
    - 76 Main St. W – Chamber of Commerce
  - e) Schedule ‘B’, Permit Fee
    - Conditional Permit - \$16 per day
  - f) Schedule ‘D’ – Parking of Large Motor Vehicles Prohibited
    - 550 Elizabeth

- 230 Main St W
  - 76 Main St W
  - King St. Public Lot - E/S King St. north of Neff St. south of Main St. West ( Plan Neff Survey Lot 1, Pt. Lot 2, Pt Lot 3)
  - 175 Main St W
  - 98 Main St W
  - 59 Charlotte St.
  - 1 and 3 Marina Drive
  - 54 Westside Road
- g) Section 3.10 “No person shall park, stand or stop a large motor vehicle in any parking lot established in Schedule ‘A’ without a valid Conditional Permit, unless it is at the time being used to make a delivery or to provide a service.
- h) Section 3.11 “ No person shall park, stand or stop a large motor vehicle in any parking lot established in Schedule ‘D’, unless it is at the time being used to make a delivery or to provide a service in loading or unloading passengers or goods.”
- i) Section 3.12 - The lands described in Schedule ‘D’ attached hereto are hereby established as Parking Lots which prohibit the parking/standing or stopping of Large Motor Vehicles.
- j) Sections 4.3 insert after daily permit “Conditional Permit”
- k) Section 4.4 insert after the fee for such permit “(s)”
