| Conditions | <p>1) That the temporary noise variance be approved for the period starting March 2024 to October 31, 2024, on Tuesdays, Thursdays, Fridays, Saturdays, and Sundays between the hours of 12:00pm to 11:00pm for a DJ with amplification equipment and live bands being able to amplify music.</p> <p>In the event, that the City of Port Colborne receives significant noise complaints from the area residents, then we would try to mitigate the noise issues by reducing noise levels, dates, times, and frequency, failing which, would result in the revocation of the noise variance permit.</p> <p>2) The permit is applicable only to the production, reproduction, and amplification of sound in connection with these events listed in the attached application. Mondays and Wednesdays have been excluded as they were not included in the application.</p> |
| Please Note | Temporary permit is valid for 2024 only and should you require relief from the noise by-law for 2025, please apply for a noise variance 60 days prior. |

Hours of Live Acoustic Bands will be:

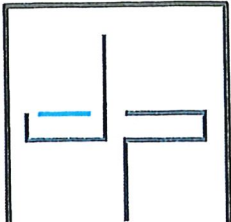
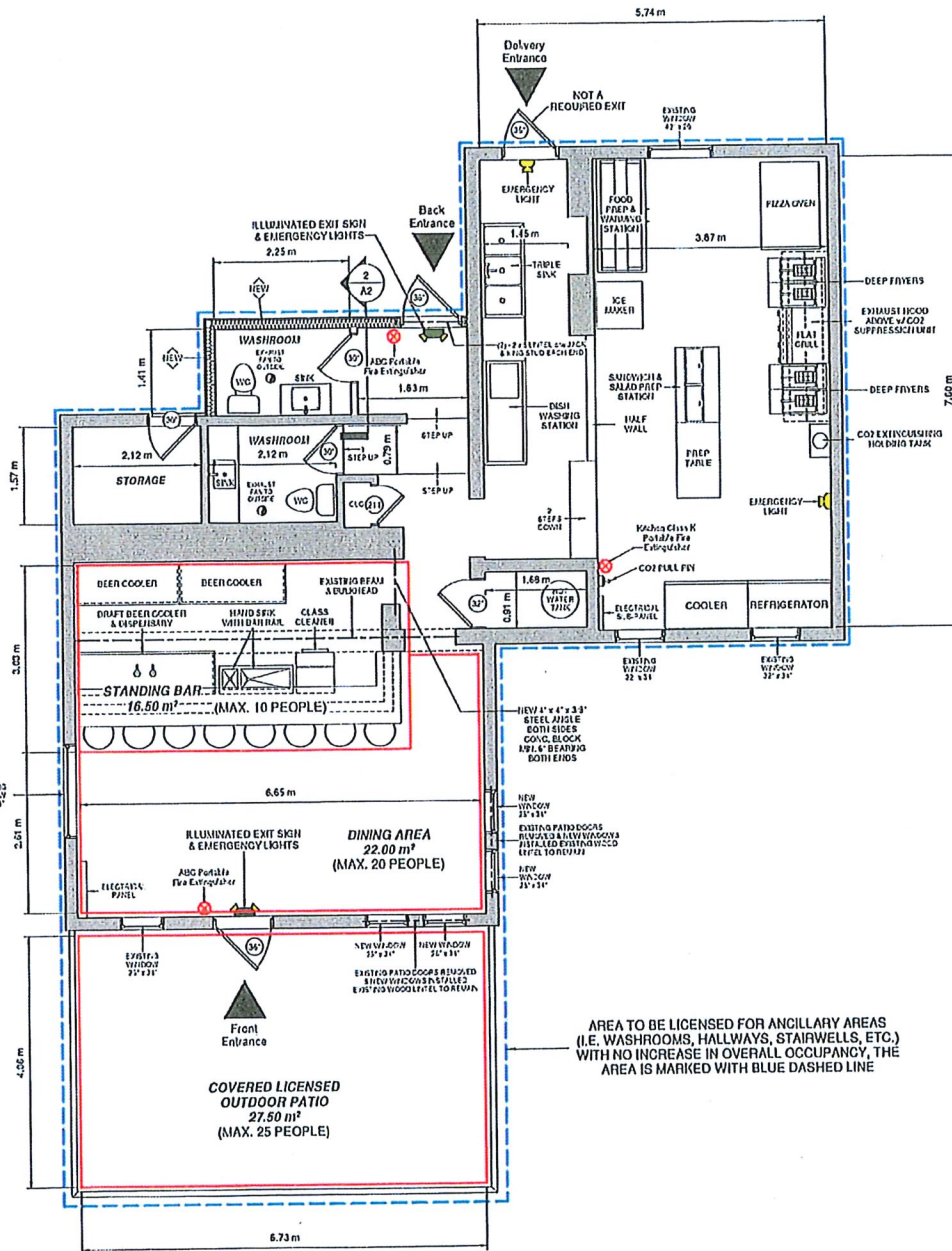

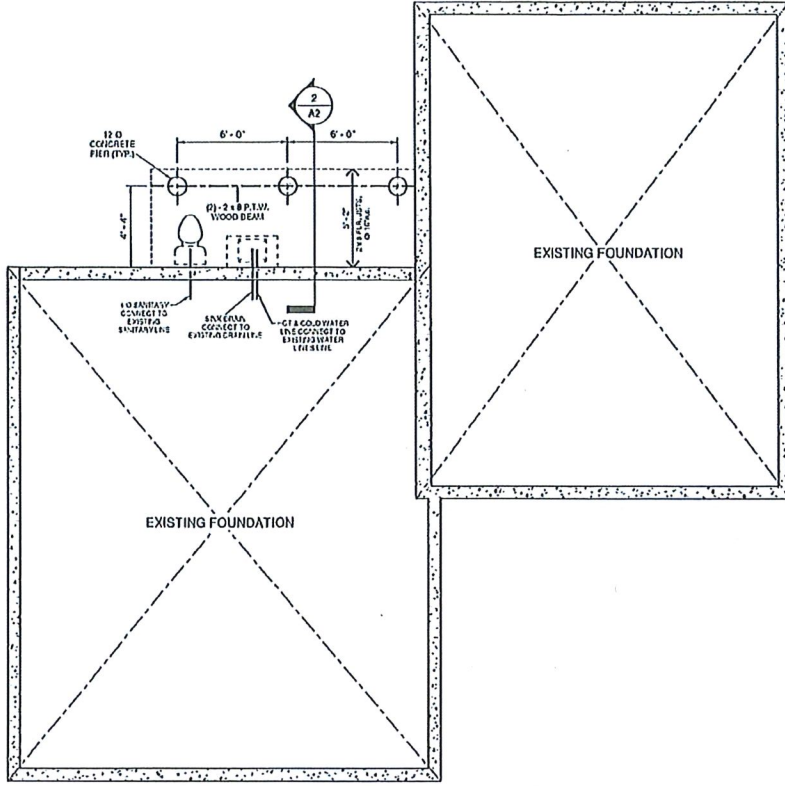

GROUND FLOOR PLAN

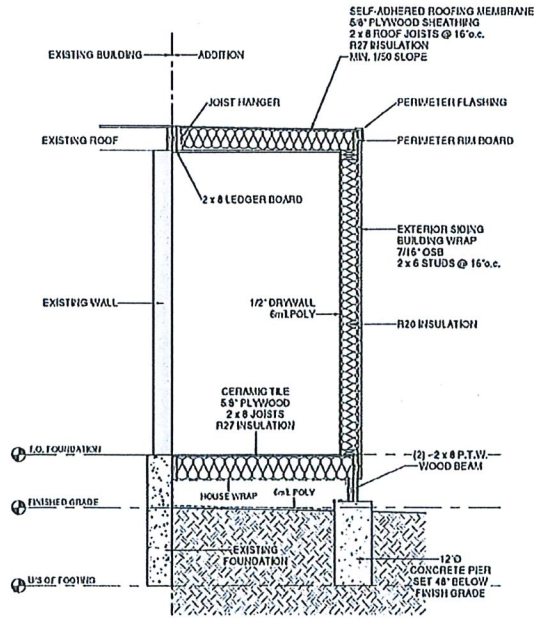
